



My Credentials

Credential requirements are set by the facilities. They are determined by your healthcare community role along with the primary areas or zones where you work. You must have a SEC³URE Passport membership to upload, store, and submit most Credentials.

COVID-19 and Seasonal Flu vaccination records are now included with the free Base membership in support of the expansion of the CMS-mandated vaccination management requirements.

Your SEC³URE membership is portable; you only need to submit credential documents one time to gain access to all SEC³URE facility locations. You will receive reminders before any credential documents expire so you never go out of compliance.

We recommend you first review the credential description and details to understand what is required and the best course of action.

Here's a key tip: Attach to and keep only the facilities you consistently visit or plan to visit in your account. This will streamline the credentials and policies you are required to submit. This also speeds-up your SEC³URE performance.



Update outstanding credentials

SEC³URE gives you several options to fulfill facility credential requirements:

Upload your credentials into SEC³URE

First save all proof document(s) *.PDF documents, *JPEG, or *PNG image. Files must be LESS THAN 8MB each. Select **Update Credentials** to upload and then submit the documents through the SEC³URE upload process. You may send multiple pages all at one time.

Here's a key tip: Make sure you read through all on-screen instructions as this is a multi-step process.



Upload via SEC³URE mobile app

The SEC³URE companion mobile app makes it easy to use your camera to snap photos of the proof documentation pages, upload, and then submit. You must agree to the Consent to Use before uploading. *Base members may not upload COVID-19 or Seasonal Flu vaccination credential information at this time.*



Submission History

Once we receive your credential submissions, we will verify and update your SEC³URE account within one business day. Look for the **Submission History** link under *Upload Your Credentials*.

Purchase titer test through SEC³URE

Ours is the only credentialing program in the nation to provide testing for both drug screening and titers as part of a comprehensive medical practitioner and vendor compliance platform. 10-panel Drug Screen, Varicella (Chicken Pox) Titer, Hepatitis B Antibody Titer, MMR Titer, and TB Titer tests are available for purchase directly through SEC³URE.

Its fast and convenient, Proof of your immunity (*a simple yes or no*) will be automatically uploaded to your SEC³URE account. IntelliCentrics will never see your detailed test results.

SEC³URE Radiation Safety

Facilities that provide imaging or use radiation-producing materials require Radiation Safety Programs. With SEC³URE, all Healthcare workers are now part of the compliance solution, closing the critical safety gap between facilities, vendors, and contractors.

Our quarterly dosimeter-monitoring program includes 1 wear and 1 control dosimeter that will be exchanged every 3 months via a pre-paid postage exchange. Your exposure profile is automatically updated in SEC³URE each quarter.

If you already have a dosimeter monitoring service, we can create a radiation safety compliance account to track requirements.

Your SEC³URE Passport membership includes access to annual radiation safety training available in SEC³URE University e-Training.



Purchase Radiation Exposure Package

Look for the shopping cart along with the **Radiation Exposure** credential requirement to purchase quarterly radiation monitoring directly through SEC³URE. We will deliver a wear and control dosimeter package to begin monitoring your radiation exposure.

At the end of the quarter, a new dosimeter set is sent to you along with a return envelope. The previous quarter's devices are returned to IntelliCentrics in a postage paid envelope. Your SEC³URE credential requirement is automatically updated with the previous quarter's readings.
